What's Going on in Woodstock?

Cort Carlson, Community and Economic Development Director for the City of Woodstock, has been involved with the ongoing renovation and restoration efforts of the Old Courthouse building and many of the other projects now underway around town. He will talk about them as well as the proposed Enterprise Zone, the property maintenance code and what that means for keeping Woodstock a quality place to live and work.



Before coming to Woodstock, Cort spent seven years as the Executive Director of the McHenry County Convention & Visitors Bureau, developing the County's first tourism marketing campaign that included the launch of visitmchenrycounty.com. He also developed its first visitor guide and achieved certification by the Illinois Office of Tourism, which enabled the CVB to greatly increase its marketing reach through state tourism grant dollars.

Here's your opportunity to get an inside look at plans for the future of Woodstock. Cort will be happy to answer your questions after his presentation, so bring plenty of them.

Committee Reports:

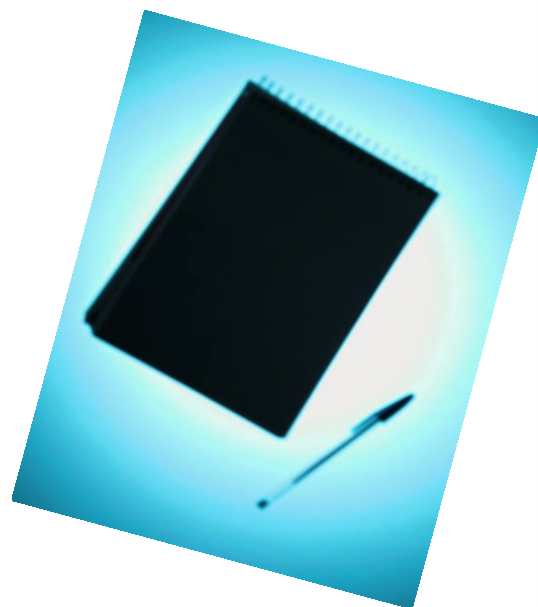
Woman of the Year – Dorene Paluch is chairing again, and asked for volunteers. Anyone interested should contact her (dtplaw@sbcglobal.net).
