**A**s part of its mission of support in achieving business and educational goals, WPBW offers women in the Woodstock area an opportunity to win a Francis Kuhn Scholarship. Named for a former WPBW member and late Mayor of Woodstock, the scholarship is awarded to deserving women returning to school on either a full or part-time basis.

Applicants must be at least 22 years old and live within the District 200 school boundaries.

This year we are awarding three \$1,300 scholarships. The money can be used for tuition, books, or other expenses related to a student's ongoing education.

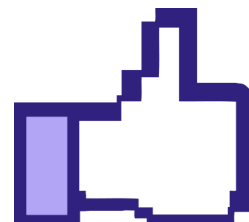
